TUITION PAYMENT PLANS:

- Payment in full due by June 1
- Payment in ¹/₂ by June 1 & ¹/₂ by Dec. 1
- Twelve (12) equal monthly payments due June 1, 2023 May 1, 2024

If you register after school starts your monthly payments will be based on a 10 month payment of total tuition DISCOUNTS:

- 2^{nd} child 5%
- 3rd child 8%, each additional child 8% each

EXTENDED CARE PROGRAM FEES
